- (iv) Descriptive Roll of the applicant, duly attested, indicating (a) height and (b) personal marks, if any, on the hand, face, etc. (Specify a few conspicuous marks, not less than two, if possible) (To be furnished in duplicate).
- (v) Certificate(s) of age (in original with four attested copies) showing the dates of birth of the children. The certificate should be from the Municipal Authorities or from the local panchayat or from the head of recognised school, if the child is studying in such school. (This information should be furnished in respect of such child or children, the particulars of whose date of birth are not available with the Head of office).

10. Indicate whether family pension is admissible from any other source Military or State Govt. and/or a public sector undertaking/autonomous body/local fund under the central or a State Government.
