**AMENDMENT**

**Subject : Standard Operating Procedure (SOP) regarding Mandatory Annual Preventive Health Check-up of Delhi Police officials from the rank of MTS to DANIPS above the above 40 years**

An SOP to implement the Mandatory Annual Preventive Health Check-up of operational staff of Delhi Police above the age of 40 years was issued vide PHQ's No.4201-4350/HAR/PHQ dated 01.10.2021.

Now, the approval of Ministry of Home Affairs (MHA) and Ministry of Health & Family Welfare (MH&FW), Govt. of India has also been received to include the "Non-operational Staff" of Delhi Police above the age of 40 years for Mandatory Annual Preventive Health Check-up vide following references :

- (ii) MH&FW OM No.Z-15025/3/2021/DIR/CGHS dated 08.04.2022
- (iii) MH&FW OM No.Z-15025/3/2021/DIR/CGHS dated 18.05.2022

In view of above, following amendment is made in the above mentioned SOP at Para - 1 i.e. Introduction :


***"Now, Annual Preventive Health Check-up Scheme is mandatory for Delhi Police Personnel above the age of 40 years from the rank of MTS to DANIPS"***

The annual Calender/Schedule for conducting proposed health check-up from CGHS empanelled hospitals of Delhi/NCR, should be finalized by each Distt. & Unit between 1<sup>st</sup> April to 31<sup>st</sup> December of the Calender Year.

Therefore, PHQ's TPM No.32747/Admn.-IV/PHQ dated 23.12.2021 and Memo. No.39461-509/Admn.-IV/PHQ dated 22.02.2022 issued earlier reg. conducting the proposed Annual Health Check up in respect of four cadres of "Operational Staff" only, is hereby withdrawn.

This has the approval of the Competent Authority.
