

THE DETAIL OF WELFARE SCHEMES RUNNING UNDER DELHI POLICE WELFARE SOCIETY AND DELHI POLICE MARTYRS' FUND FOR WELFARE OF DELHI POLICE PERSONNEL

A. DELHI POLICE WELFARE SOCIETY(S.O. No. 19)

The Delhi Police Welfare Society is registered under the Societies Registration Act. The Society is also registered with Income Tax U/S 12-A & recognized U/S 80-G of the Income Tax Act, 1961.

The Delhi Police Welfare Society has been introduced w.e.f. 1.4.1990 and administered by a Managing Committee as mentioned note para 3 of S.O. No. 19. The object of the society is to provide all the existing benefits which are available under "Delhi Police Welfare Funds" at the same or enhanced levels alongwith additional benefits of saving maturing at the time of superannuation. A sum of Rs. 200/- per month (including Rs. 100/- non-refundable) (increased from 150/- PM to 200/-PM w.e.f. 6.07.2019) is being deducted as subscription from the pay of all ranks of the police personnel including MTS.

The following types of financial assistance are being paid from the Delhi Police Welfare Society:-

B. Delhi Police Martyrs' Fund (S.O. No. 421)

Delhi Police Martyr's Fund is registered under the Societies Registration Act. The Fund is also registered with Income Tax u/s 12A and recognized u/s 80-G of Income Tax Act, 1961.

Delhi Police Martyr's Fund has been introduced w.e.f. 1.2.2013 to provide inter-alia, immediate monetary assistance to the families of its members, who lay down their lives during the course of government duty. The fund is administered by a Governing Body as mentioned at para 3 of S.O. No. 421/2013. Initially, one day gross salary was contributed by its members to create corpus for the fund. To increase the fund, monthly deduction of Rs. 10/- to 100/- PM rank wise (MTS, CT. & HC – Rs. 10/-, ASI – Rs. 20/-, SI – Rs. 30/-, Inspr.- Rs. 40/-, ACP – Rs. 50/-, DCP -Rs. 60/-, Addl. CP- Rs. 70/-, Jt. CP to C.P.- Rs. 100/-) is being made from all police personnel w.e.f. 1.10.2015. The following type of financial assistance is granted to the family of its members:-

1	In the event of 'death' while performing govt. duty.	Rs.15,00,000/- (in lump-sum)
2	In the event of a death involving gallantry in the line of duty caused solely and directly by external violence.	Rs.30,00,000/- (in lump-sum)
