ORDER

An e-tender for the purchase & installation of 400 Nos. Traffic Police Booths for housing the battery back-up system and facilitation/stationing for Traffic Police Personnel for use in Delhi Police (Traffic Unit) was opened on 19/3/2018 in which 13 (thirteen) firms including your firm had participated in the tender. After completing/following the tender procedure, on 27/6/2018, price bids of the five firms, who were declared technically qualified by the Technical Committee including your firm, M/s. Aasra Martech Private Limited, Ground Floor, D-90, Gate No. 4, IGNOU Road, Neb Sarai, New Delhi-110068 and your firms was found to be L-1. Finally, M/s. Aasra Martech Private Limited, New Delhi had agreed to supply/install 400 Nos. Traffic Booth at a total cost of Rs.6,76,00,000/- (Rupees Six Crore Seventy Six Lakh only) (including GST @ 18%) @ Rs. 1,69,000/- each (including taxes) and CAMC thereof at a total cost of Rs.2,31,30,360/- (Two Crore Thirty Lakh Thirty Thousand Three Hundred Sixty only) (including taxes) for four years after expiry of guarantee/warrantee of three years. The Competent Authority vide letter dated 04/10/2018, had accepted/approved the offer of the firm with the condition that availability of land (NOC from land owning agencies) for installation of requisite 400 Nos. Traffic booths before placing order to the firms. Accordingly, Traffic unit had obtained NOC from land owning agencies for installation of Traffic Booths at different location and your firm was asked for bid extension on the same rates and terms & conditions of tender for supply and installation of 300 Nos. Traffic Booths.

In pursuance of the request, on 26.8.2019, M/s. Aasra Martech Private Limited, New Delhi submitted letter and agreed the following:-

1. To execute the work for any quantity exceeding 300 Traffic Booths.

O-I/II/II2. To execute the work at their earlier negotiated rate of Rs. 1,69,000/- each.

KPR./COM3: To keep these rates valid till March 31,2020.

 All other terms & conditions remain same as mentioned in earlier letter dated 21.5.2019.

Accordingly, revised expenditure sanction/approval of competent authority for purchase of 300 Nos. Traffic Booths for Rs. 5,07,00,000/- (Rupees Five Crore and Seven Lakh only) (including taxes) and award of CAMC thereof at a total cost of Rs.1,73,47,770/- (Rupees One Crore Seventy Three Lakh Forty Seven Hundred Seven Hundred and Seventy only) (including taxes) for Four (4) years after expiry of guarantee/warrantee of three years was obtained in favour of your firm i.e. M/s. Aasra Martech Private Limited, New Delhi vide letter No. 22968/Admn. (V)/PHQ dated 14/10/2019. In turn, your firm was requested to deposit security money of Rs. 50,70,000/- (Rupees Fifty Lakh Seventy Thousand only) in the shape of Banker Cheque/Demand Draft or BG/FDR valid for a period of 3 years and 7 months as per provisions of clause No. 10.2 Chapter-1 and

Clause No. 2, Chapter-2, of tender terms & conditions vide this office letter No. 15540/CSA/Q-I(B)/DCP/P&L dated 21.10.2019. However vide letter dated 24.10.2019, your firm requested to clarify the following:-

- The agreed rate for supply is Rs. 1,69,000/- for 1 no. booth and the amount of 300 booths is Rs. 5,07,00,000/-. Thus, supply amount is Rs. 5,07,00,000/-
- 2. The amount of maintenance charges are Rs. 1,73,47,770/-.
- 3. Total amount of order is Rs. 6,80,47,770/-

Necessary clarification was conveyed vide letter No. 15994/CSA/Q-I(B)/DCP/P&L dated 30.10.2019 to your firm that both the rates for purchase of 300 Nos. Traffic Police Booth and CAMC thereof are separate and the firm was again requested to deposit security money. Further, reminders for deposition of security money were also issued vide letter Nos. 17334/CSA/Q-I(B)/DCP/P&L 19053/CSA/Q-I(B)/DCP/P&L 4.12.2029, dated 19.12.2019 956/CSA/Q-I(B)/DCP/P&L dated 17.1.2020. Vide letter No. 956/CSA/Q-I(B)/DCP/P&L dated 17.1.2020, the firm was requested to deposit security money within 7 days failing which necessary action as per tender terms & conditions shall be initiated against the firm. Since the firm failed to deposit security money, a Show Cause Notice of Default for Blacklisting was issued to M/s. Aasra Martech Private Limited, New Delhi vide No. 1737-43/CSA/Q-I(B)/DCP/P&L dated 11.2.2020 as per provisions of clause No. 10.2 Chapter-1 and Clause No. 2, Chapter-2 of tender terms & conditions.

M/s. Aasra Martech Pvt. Ltd., New Delhi vide letter dated 10.2.2020 (received on 13.2.2020 in this office) stated that due to delay caused in finalization of tender, there has been escalation in the cost of construction and rates of material labour installation charges. As such, it has become virtually impossible for the company to carry out the construction and installation of the Traffic Police Booths on the rates quoted and agreed. The firm also sought opportunity for personal hearing. Accordingly, your firm vide letter No.2 517/CSA Q-1(B)/DCP/P&L dated 27/02/2020 given an opportunity for personnel hearing.

Shri Sanjay Sharma and Shri Sandeep Mittal of M/s. Aasra Martech Pvt. Ltd., New Delhi also attended the office of undersigned on 4.2.2020 and put no fresh plea or grievances except what had already mentioned in letter dated 10.2.2020. The representatives of the firm were informed that your firm vide letter dated 26.8.2019 has already agreed that the rates will be valid till 31st March, 2020. Accordingly, after obtaining necessary expenditure sanction of competent authority, your firm was requested to deposit security money vide this office No. 15540/CSA/Q-I(B)/DCP/P&L dated 21.10.2019. As such, the plea put forth is not tenable as per provisions contained in clause No. 10.2 Chapter-1 and Clause No. 2, Chapter-2, of tender terms & conditions. However, the representatives of the firm sought 7 days time to submit further reply.

Till 13.3.2020, no reply was received from your firm. As such, it was again requested vide this office letter No.3388/CSA/Q-I(B)/DCP/P&L dated

13.3.2020 to supply your reply/consent within 3 days positively failing which necessary decision on show cause notice shall be taken ex-parte. However, your firm has failed to submit the reply till 23.3.2020.

From the above facts, it is clear that you, M/s. Aasra Martech Pvt. Ltd., New Delhi, have failed to deposit the Performance Security Money after being given ample opportunities, which shows a very unprofessional and unethical approach of your firm in honouring your commitments of letter dated 26/08/2019 and clause No. 6.4 Chapter-1 of tender terms & conditions. Therefore, you have wasted the precious time and efforts of the officers involved in above said process, besides depriving the Department in procurement of Traffic Police Booths.

Keeping in view of above, I am Inclined to take a decision on the show cause notice issued vide No. 1737-43/CSA/Q-I(B)/DCP/P&L dated 11.2.2020. Therefore, I, D.K.S. Singh, IPS, Deputy Commissioner of Police, Prov. & Logistics, 5, Rajpur Road, Delhi-110054 do hereby blacklist your firm M/s. Aasra Martech Private Limited, Ground Floor, D-90, Gate No. 4, IGNOU Road, Neb Sarai, New Delhi-110068 from Delhi Police work for a period of two years from the date of issue of order.
