ILLEGAL STAKING / GAMBLING ACTIVITY BUSTED BY SPECIAL STAFF, EAST DISTRICT; THREE ACCUSED ARRESTED

- **03 accused apprehended red-handed while indulging in illegal staking**
- **Cash stake Money of Rs. 12,090/- recovered**
- **Betting slips and diary seized**

BRIEF: -

In a continued drive against unlawful activities, the Special Staff of East District Police successfully busted an illegal staking/gambling activity being carried out at a public place in the Kalyanpuri area. Acting on specific intelligence, the police apprehended three persons red-handed while indulging in illegal gambling. Cash stake money and betting material were recovered from their possession.

INCIDENT & INVESTIGATION: -

In view of the ongoing special drive against crime and criminals, a dedicated team comprising HC Vichitre Kumar, HC Naresh, and HC Vinit of the Special Staff, East District, led by Insp. Jitendra Malik and working under the supervision of Sh. Sanjay Singh Addl. DCP/Operations, was constituted.

On 09.01.2026, HC Vichitre Kumar of Special Staff, East District, received specific secret information regarding illegal staking/gambling being conducted near Trilokpuri Park, in front of Block-23, near a public shauchalaya, within the jurisdiction of Police Station Kalyanpuri. After discreet verification of the information, the team promptly reached the spot and conducted a raid. During the operation, three persons were found actively involved in illegal staking activities and were apprehended on the spot. Upon thorough checking, a total cash amount of Rs. 12,090/-, and other gambling-related material were recovered from the accused persons. Accordingly, a case FIR No. 0014/2026 U/s 12/9/55 Gambling Act, 1955 was registered at PS Kalyanpuri. Further investigation is in progress.

MODUS OPERANDI: -

The accused persons used to assemble at a public place to avoid suspicion, where they conducted illegal staking/gambling among local participants by verbally accepting bets, recording the details on paper and plastic slips, and collecting and circulating cash stake money on the spot.

PROFILE OF ACCUSED PERSONS: -

- 1. Accused Deepak Kumar**, aged about 35 years, is a resident of Trilokpuri, Delhi. He is a local resident of the area and was found actively involved in illegal staking activities at a public place. He allegedly played a key role in managing and handling the cash stake money during the gambling activity.
- 2. Accused Govind**, aged about 26 years, is also a resident of Trilokpuri, Delhi. Being familiar with the local surroundings, he allegedly participated in illegal staking by assisting in accepting bets and maintaining betting slips at the spot.
- 3. Accused Mohd. Amir**, aged about 34 years, is a resident of Shastri Mohalla, Shashi Garden, Delhi. He allegedly facilitated the gambling

activity by coordinating with participants and supporting the recording of bets during the illegal staking operation.

RECOVERY: -

- Cash stake money – **Rs. 12,090/-**
- Betting slips (paper and plastic sheets)
- 01 Mobile Phone
